# **CHAPTER I**

# **INTRODUCTION**

#### 1.1 Background of the Study

Communication in every activity carried out by humans as social beings is a necessity. There are several ways to communicate, and language is one of the most important things in communication. Languages that humans can use consist of written language, body language, spoken language, and other languages. However, the most used by humans is spoken language. It becomes the main tool of communication and cannot be committed or replaced. The rapid development that occurs in communication has created many new forms of interaction. Pragmatic perspective can interpret the meaning of a sentence delivered by someone. in using English for spoken language, knowledge of norms is also needed. About the way, someone uses the language to talk to people of higher degrees such as the royal family. In this study, the researcher will focus on how the main characters in the film *A Royal Night Out (2015)* in conveying their opinions to capture the intended meaning according to a pragmatic perspective. In addition, researchers will discuss the differences in spoken languages used by royal families and ordinary people according to the pragmatic perspective obtained. Because, based on the mini-survey that researchers did before with 24 respondents ages around 20-26 years old from different backgrounds such as a boss, customer service, student, and so on. The mini-survey is giving information that respondents to know about the royal family from the movie. Most of them are interested in the story of the royal family, but no one of them explains the norms in the royal family, how ordinary people speaking with the royal family, and also how royal family speaking in their environment. Therefore, from this research, the readers will get more information about it.

### **1.6 Definition of Terms**

#### 1. 6.1 Spoken Language

In spoken language, much of the meaning is determined by the context. That contrasts with written language in which more of the meaning is provided directly by the text. In spoken language, the truth of a proposition is determined by common-sense reference to experience, but in written language, a greater emphasis is placed on the logical and coherent argument. Similarly, spoken language tends to convey subjective information, including the relationship between the speaker and the audience, whereas written language tends to convey objective information (Tannen, Deborah 1982).

# 1.6.2. Pragmatics

Pragmatics as a field of linguistic inquiry was initiated in the 1930s by Morris, Carnap, and Peirce, in a Hornbook. Whom syntax addressed the formal relations of signs to one another, semantics the relation of signs to what they denote, and pragmatics the elation of signs to their users and interpreters (Morris 1938). In this program, pragmatics is the study of those context-dependent aspects of meaning which are systematically abstracted away from in the construction of content or logical form (Horn, 2006).
