In the stream done earlier by our Livers (A Message from NIJISANJI EN), it was mentioned that parts of information received from Selen and her lawyer was shared to them by ANYCOLOR Inc. As mentioned in that stream and in the notice published by ANYCOLOR Inc. (Notice: Termination of Selen Tatsuki's Contract with ANYCOLOR), Selen and her lawyer claimed that "Livers affiliated with ANYCOLOR Inc. were involved" and that they will hold ANYCOLOR Inc. legally responsible. Selen and her lawyer mentioned the possibility that they will also hold Livers affiliated with ANYCOLOR Inc. legally responsible. In order to check the validity of Selen and her lawyer's claim, ANYCOLOR Inc. shared only necessary parts of the information sent by her lawyer with our Livers and led an internal investigation. obligation regarding the information shared to them from ANYCOLOR Inc. Thus, there are no legal issues regarding the information shared to the public in the stream made by our Livers. After a rigorous legal check, ANYCOLOR Inc. hereby declares that it has not made any confidentiality violations while checking the validity of claims made by Selen and her lawyer with its affiliated Livers.
